AND WHEREAS the founder has been cherishing a desire to an endowment in memory of his parents Late Kunji Lal Agarwal and Late Smt. Gulkandi Devi dedicated it in perpetuity for the promotion and development of the objects here in mentioned in this deed. In pursuance of such desire, the founder has irrevocably settled the said property upon trust for public charitable purposes and has handed over, prior the execution of this deed, the said property to the trustees to be held as the corpus of the trust.

AND WHEREAS it is the desire of the founder that the corpus of the trust must be further augmented from time to time by receipt of funds, movable & immovable properties and other articles by way of donations or contributions.

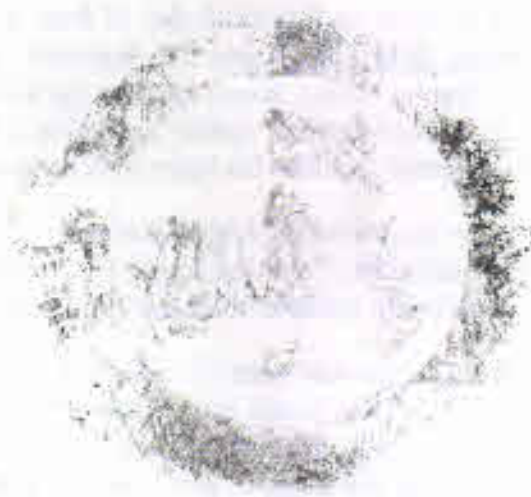

OBJECTS OF THE TRUST:

5. The trustees shall stand to be possessed to the said trust fund upon trust to receive the interest, dividends, and other income thereof and in the first place to reimburse themselves or pay and discharge all the costs, charges and expenses incurred in or about or incidental to the administration or execution of the trusts or powers of these presents and also all outgoing taxes, rates, assessments, dues, duties, levies and other taxes payable in respect thereof and the cost of meeting of ordinary repairs to any immovable property if for the time being subject to the trusts of these presents and subject thereto upon trust to apply the residue of the said interest, dividend and other income (hereinafter called "the said income") and at their discretion to apply the whole or any part of the corpus of the Trust Fund for the following aims and objects in India or outside India.

(g) To accept donations, raise subscriptions, from the members of the trust or other persons, to invest the funds of the trust with such individuals, societies, firms or companies, for providing income to the trust, on such terms and conditions as may be deemed proper and necessary for the fulfilment of the aims and objects of the trust and in furtherance of its interest as enumerated above.

(h) To award prizes, medals and that like in universities, colleges, schools etc, to encourage students for higher, better and quality education.

(i) To do any other act or thing which is ancillary to the achievement of any of the above stated objects for the benefit of the public at large.

(k) All the income, earnings, movable or immovable properties of the trust shall be solely utilised and applied towards the promotion of its aims and objects only and no portion thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profit or in any manner whatsoever, to the present or past trustee or to any person claiming through any one or more of the present or the past trustees. No trustee of the trust shall have any personal claim on any movable or immovable properties of the trust or make any profit, whatsoever, by virtue of his trusteeship.

8. The Trustees shall maintain a true and correct record of the receipts, payments incomes and expenses and transactions of the Trust. The accounting period of the Trust shall be period ending on 31st March every year.

9. The accounts shall be duly audited with all necessary vouchers at least once in every year by chartered accountants as the trustees shall appoint and pay for the purpose.
10. The audited accounts of the trust shall be placed before the general meeting of the trust within six months of the end of each financial year or as may be decided by a majority of trustees in writing.

MANAGEMENT OF THE TRUST:

11. The general management and control of the trust for the purpose of managing the trust affairs and properties which includes any business undertaking vested in trustees and carrying out the objects of the trust aforementioned is vested in the trustees and for this purpose without prejudice to all powers mentioned above, the trustees have got powers to enter into partnership and other contracts borrow money and furnish security as may be considered necessary by the trustees.
12. The first meeting of the trustees shall be held within four months from the date of this deed and shall be summoned by seven days' notice in writing to be given by the Chairperson or any three of the trustees to all the other trustees and shall be held at such time and place as shall be specified in such notice and be the first annual general meeting of the trustees. A general meeting of the trustees shall be held once at least in every year subject to the provisions of this present clause the meeting of the trustees shall be held on such occasions at such times and places and with such notice and the business to be transacted at such meeting shall be conducted and the resolutions and proceedings of such meeting shall be recorded and proved in such manner as rules made from time to time.

POWERS, FUNCTIONS AND DUTIES OF THE TRUSTEES:

16. The trustees have the following powers:

PROHIBITIONS FOR TRUSTEES:

PROFESSIONAL SERVICES BY A TRUSTEE:

19. Any trustee who being a professional or any firm in which he or she be a partner is engaged or employed in any professional capacity to act for this trust or do any work for this trust may be remunerated out of the income of the trust fund by the trustees for such professional works he or she or such firm shall be entitled to charge this trust for any professional services rendered to this trust by such trustees or by such firm.

NUMBER, APPOINTMENT & RETIREMENT OF TRUSTEES:

20. If at any time the number of the trustees is less than three the existing trustees shall appoint one or more trustees at their discretion, but in any case, the total number of trustees including the new trustees to be appointed shall not exceed seven.
21. Upon the appointment of a new trustee, the trust properties shall vest in the new trustee jointly with the continuing or surviving trustees with the power and subject to the trust hereby created.
22. Any of the trustees may retire on giving one month's notice in writing to the other trustee or trustees
23. If any trustee shall die or retire or become incapable or unfit to act, the continuing or surviving trustee or trustees shall be entitled to appoint a successor in place of the trustee dying or retiring or becoming incapable or unfit to act, preference to be given to the near relative of the settlor.

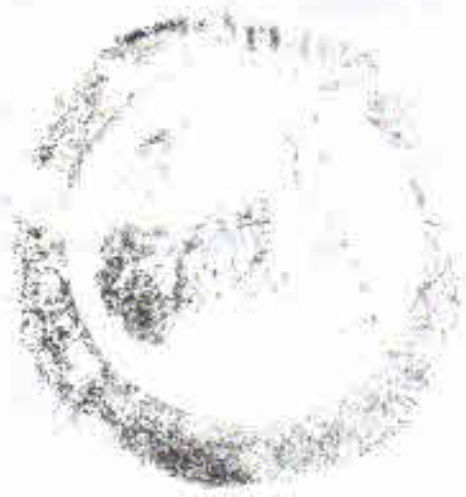

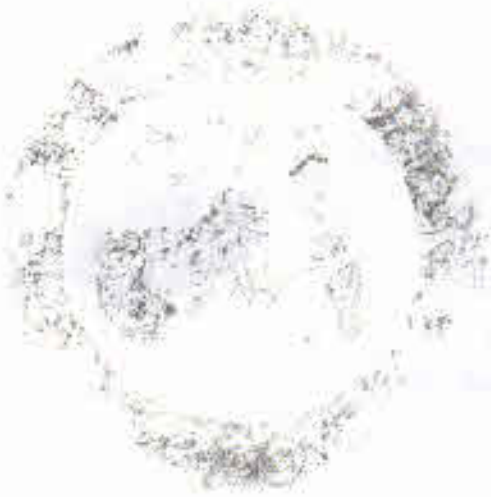
